The program is called Hallway Heroes, which invites parents to greet students as they arrive at school; help with lunch and/or recess duties; monitor hallways, entryways, parking lots, and playgrounds; assist office personnel and teachers with daily support tasks; eat lunch or play on the playground with a student, etc. (K.
