1: Jointly Developed Expectations and Objectives

- Stagecoach Elementary's leadership committee will involve parents and community members on the development of Stagecoach's Family and Community Engagement plan. After the plan is developed and the staff of Stagecoach give feedback, the committee will be asked to review and give feedback. The plan will help to accomplish collaboration by having a small, diverse committee of parents involved in the plan. Based on feedback, changes will be considered. The committee will review, update and evaluate the Family and Community Engagement plan at least annually. (Jessica House, May 2023)
- Parents will be adequately represented in a variety of roles at Stagecoach through numerous volunteer opportunities that will be communicated via teacher emails, school newsletter, social media, etc. Examples of volunteer opportunities could include working in the workroom, assisting at special school events, completing projects at home, or mentoring students. - Based on a survey addressing parent/guardian needs, the results indicated that numerous students do not have a personal device at home. To address this, the Cabot School District is providing a computer for each student. Stagecoach did not use consistent communication methods from classroom to classroom. Teachers will streamline parent communication through the use of Google Classroom. In the event of an extended closure, Stagecoach Elementary will provide rigorous instruction via the Cabot School District Ready for Learning Plan. (Carol Skiba, ongoing)
- Parent/Teacher organization is enabled at Stagecoach. (Carol Skiba, August 2022)
- Parents will be asked to engage in discussion of how they can support Stagecoach Elementary. Parents will also be given the opportunity to suggest ideas for coordinating school-parent efforts and explanations of grading procedures. (Carol Skiba, Ongoing)
- Parents will be asked to complete an interest survey to gather information about activities that would be beneficial to support their child academically.
