Meeting was called to order at 3:45 pm.

Sue Ann Whisker introduced new committee members representing Cabot High School: Alec Park, Dylan Glover, and Kim Usery.

Food Services - Erin Wilkes, Director of Food Services discussed the following reports: Quarterly menu review, written food and beverage locally recommended list, written recommendations to the Cabot School Board regarding the components for food and beverage vending contracts.

Cabot Health Unit - Carey Woods, Administrator - No report

District Program Updates - Michael Byrd, Assistant Superintendent reported that the district had acquired a facility on South Pine Street just east of Tractor Supply. Today was the bid opening for renovating that facility. This facility will soon house the District Health Services and the Cabot Museum. This will provide much needed space for our expanding health service staff and the delivery of services.

School Health Programs – Kelly Spencer, Health & Wellness Coordinator reported that administrators are in the process of completing the School Health Index evaluation for SY 20-21. The SHI is the evaluation tool used to assess Health and Wellness goals from each building's Indistar School Improvement Plan. Some administrators may be contacting wellness committee members to assist with this evaluation.

Due to COVID restrictions, the Cabot Cruisers have decided to cancel the 2021 Spring Fling 5K/Kids' Fun Run. The hope is to resume in 2022. This program is an integral part of District PE Fundraising, as well as it is a great opportunity to work with our community partners to promote fitness for students, staff, and community members.
