Meeting was called to order at 3:40 pm.

Reports:

District Update – Michael Byrd, Deputy Superintendent, reported that District departments are working with the School Board on the board to PLC process. He provided an update on construction projects including pK center, playground equipment, CLA certificate of occupancy has been provided and will open in January. The CLA to daycare renovation will begin soon. The MSN car rider line renovation is almost completed.

Health Services – Vonda Morgan, Director of Nursing, reported that schools are continuing to work with Project ADAM, setting up response teams and making campuses Heart Safe.

Counseling Services-Emily Taylor, Directors of Counseling Services reported the start of Circles of Hope, which is a program in which CHS students are working with middle school students on teaching and modeling coping skills. The first Panther Camp at WS took place where students toured the CTE programs. She also reported that Cabot Parks and Recreation gave over \$15,000 of food donations to the district.

Safety & Security - Morris Rothfeldt, Executive Director for Support Services, reported that black out shades should be completed by semester break. After break, NARCAN kits will begin to be delivered. Stop the Bleed kits have been delivered to schools. The goal is to eventually have one in each classroom. Mr. Rothfeld has attending training on stadium and events security. This training focuses on risk management, crowd management and crisis management. Finally, the Comprehensive School Safety Assessment mandated by the LEARNS Act is due for each campus by August, 2024. He and his team of School Safety Coordinators will be working to complete this work.
