This form needs to be completed to assign a student to a bus.

It is the goal of the Cabot School District's Administrators, Transportation Department, and Drivers to ensure the health and safety of ALL student.

Students are only allowed to ride the bus to which they are assigned.

PARENTS MUST CONTACT PRE-K DEPARTMENT FOR TRANSPORTATION REQUESTS.

ONLY THE TRANSPORTATION OFFICE CAN ADD NEW STOPS.

## Student Expectations for Riding a Cabot School Bus

For the safety of your child, and all others riding Cabot School District buses, please discuss the following expectations with your child. A list of rules for the bus is available in the Student Handbook, pages 54-55.

- 1. Students need to be at the bus stop 10 MINUTES PRIOR to the scheduled bus stop time.
- 2. Students should refrain from using loud voices or making loud noises on the bus. Loud noises are a distraction to the driver and create an environment that is not ideal for transporting students.
- 3. For their safety and the safety of others, students must remain seated, in their assigned seat, until the bus comes to a **COMPLETE STOP**. Students should also keep their feet, legs, arms and other body parts out of the aisle and inside the windows.
- 4. In times of extreme heat, students may need to have water on the bus. Students choosing to have a drink on the bus need to take care of any trash they bring on the bus or their privilege to may be revoked.
- 5. No glass containers, animals, bugs, or other critters, dead or alive, may be carried on the bus. Other transportation arrangements must be made to get them to school.
- 6. Throwing objects creates a danger for the driver and passengers and will **not** be tolerated on the bus or at the bus stop.
- 7. Due to the number of students riding Cabot buses and because there is no storage room inside the bus, we must limit the allowable size of student carry-on items. **STUDENTS CAN CARRY WHAT THEY CAN SAFELY HOLD IN THEIR LAP.** This includes backpacks, band instruments, projects, etc.
- 8. Actions and behaviors that put other riders at risk of injury, such as creating a dangerous environment for the bus driver to perform their normal driving responsibilities, fighting, or possessing items prohibited at school, will result in discipline up to, and including, suspension from school and loss of bus privileges.

Bus drivers will address student behavior that does not meet the above expectations and will contact a parent or guardian if behavior does not improve. The student will be referred to school administration if parent/guardian contact is not effective in correcting problem behavior. If you have transportation questions or would like to speak with a driver, please call the Transportation office at 501-743-3531. Please do not board a bus to speak to a driver. Act 247 of 2005 prohibits unlawful entry by unauthorized person on school buses.

Students responsible for damage on a bus will be liable for repairs. For example, the cost to repair a damaged seat is \$80.00 Please address this with your student. Video cameras on Cabot buses may be used to help resolve situations.
