CURRICULUM REPORT

Special Services — **ESOL** — Bianca Pernillo introduced the district's English for Speakers of Other Languages (ESOL) staff. Cabot has 492 language minority students with 306 of them having limited English. There are 21 total languages represented in the Cabot School District. ESOL students receive support throughout the day in general education classes, and they also have special opportunities set aside to focus on English. The Seal of Biliteracy launched at the high school in 2020, and 40 students received this designation last year.

Legal Transfer Approvals – Dr. Thurman reported that 6 outgoing legal transfers were approved and 1 incoming legal transfer was approved.

Buildings and Grounds Report – Michael Byrd reported that the roof is complete on Pre-K North and is 75% complete on Pre-K South. The carpet removal in the Fine Arts Auditorium is complete. Plumbing rough in has started in the special programs' addition at CAO. Framing has started in the locker room expansion at the field house.
