MINUTES OF THE FEBRUARY 25, 2025 BOARD OF EDUCATION CABOT SCHOOL BOARD

Board President Joe Trusty called the meeting to order at 6:02 p.m. Those in attendance were school board members Pam Clem, Corey Williams, James Hertzog, Kevin Tipton, Marvin Jones and Sarah Owen. Also, in attendance were Dr. Tony Thurman, Michael Byrd, directors, and community members.

The Pledge of Allegiance and moment of silence were led by Magness Creek Elementary student Gracie Van Dorple.

CONSENT AGENDA

Minutes from the regular January 30th meeting were approved as presented. January financials were approved as presented. Motion by James Hertzog, second by Marvin Jones; passed 7-0.

RECOGNITION

Eagle Scout Recognition – Dr. Thurman recognized three Cabot High School students for earning the distinction of Eagle Scout: Blake Wilbur, Kaleb Wilbur, and Spencer Byrd. To earn this distinction, each scout had to complete a service project. Blake planted trees at Reeds Bridge Civil Ward Park in Jacksonville. Kaleb leveled headstones and made some grave markers at the cemetery at Reeds Bridge. Spencer removed broken curbing and cleaned the area around the museum at Camp Robinson.

Student Spotlight – Gracie Van Dorple was recognized from Magness Creek Elementary for her 'go-getter' personality, leadership, and creativity. She is willing to take on any challenge and always makes it magnificent. She currently does a segment called "Getting to Know You with Gracie" for the "News from the Creek" group.

Sean Rogers was recognized from Cabot Learning Academy for his resilience, both academically and socially. He strives to learn and shows great courage in moving forward. Sean created a desk and flag for the class guinea pig's cage.

PLC Building Recognition – Emily Cain, ed tech at Magness Creek Elementary, is extremely creative and identifies students' strengths and helps them build confidence and skills through those strengths. She started a coding club that meets in the mornings before school, and she also oversees the "News from the Creek" group.

CURRICULUM REPORT

CTE Program Update – Nicole Gatewood provided an update on the CTE program, which includes 19 pathways. Cabot students earn approximately 1200 certificates annually, and there are 469 completers on target for this year. Most pathways have a competitive component. Cabot High School has a 100% pass with the 27 students in the CNA program. This year we have 15 students who are in the intern program with Unity Health to shadow doctors.

Legal Transfer Approvals - Dr. Thurman reported that 1 outgoing legal transfer was approved.

Buildings and Grounds Report – Michael Byrd reported that the canopies at both pre-k buildings have been installed and sheetrock is going up inside. Carpet will be replaced at CAO over spring break. The roof is going up at the special programs' addition to CAO. Weights have been delivered to the fieldhouse, and they are working on the epoxy floors. The fieldhouse renovations are still on target to be completed in April.

Upon returning, the board voted to uphold the administration's recommendation to expel student 4602 for the remainder of the 2024-2025 school year.
