## MINUTES OF THE JUNE 18, 2024 BOARD OF EDUCATION CABOT SCHOOL DISTRICT

Board President Joe Trusty called the meeting to order at 5:32 p.m. Those in attendance were school board members Pam Clem, Sarah Owen, Corey Williams, James Hertzog, and Marvin Jones. Also, in attendance were Dr. Tony Thurman, Michael Byrd, directors, and community members. Board member Kevin Tipton was absent.

The Pledge of Allegiance and moment of silence were led by Board President Joe Trusty.

#### CONSENT AGENDA

Minutes from the regular May 21 and special called June 10 meetings were approved as presented. May financials were approved as presented. Motion by Sarah Owen, second by James Hertzog; passed 6-0.

#### CURRICULUM REPORT

**Special Programs Report** — Andrea Mendoza and Kellye Bing provided an overview of the ESY program, which is being held at Westside Elementary this year. This program is no charge to students and every student with an IEP is eligible to participate. It is designed to prevent regression and is not summer school or credit recovery. The program is held Tuesday through Thursday for five weeks and consists of a morning session and an afternoon session. This year 61 students are participating in the program.

#### SUPERINTENDENT'S REPORT

**Legal Transfer Approvals** – Dr. Thurman reported that four outgoing legal transfers were approved and ten incoming legal transfers were approved.

**Buildings and Grounds Report** – Michael Byrd reported that eight or nine bays are up at the practice pavilion and electrical is being installed. The projected completion date is estimated as September of this year. Classrooms have been set up in the CPS Child Development Center. Carpet removal is ongoing in the district and several buildings are at the punch list phase. They are working on some final details on the MSN inclusive

playground and then the district's inclusive playground project will be complete. Middle School South has received new lighting and paint in the cafeteria, and Middle School North will receive an office renovation.

Free and Reduced Lunch Percentages – For information.

**Spring 2024 Student Activities** – Scott Reed and Kasey Wylie shared that we had 1836 students participate in athletic activities in the 2023-2024 school year, compared to 1657 in the 2022-2023 school year. Thirty-three athletes signed for college scholarships, 11 athletes were selected for all-star teams, and 3 coaches were selected as all-star coaches. The district also had two state champions: Cabot High School cheer and boys wrestling.

SUPERINTENDENT PRE-ACTION REPORTS

**Refunding of Construction Bonds** – **Series B, Dated July 11, 2024** – Jack Truemper of Stephens, Inc. reviewed the refunding documents and financials for the bond. The resolution includes a new MA agreement since the bond issue size changed. Robert Baird & Co., Inc. was the winning bidder at 4.176259%, and it is a five-year call.

**ESSA and IDEA Assurance and GEPA Statement** – Dr. Thurman reviewed the assurances that were presented.

**2024-2025 CPS Child Development Center Salary Schedule** – Tina Wiley explained that the contract days were decreased to 190 days from 195 days on the CPS Child Development Center salary schedule.

**Wilbur Mills Co-op Voting Designees** – Dr. Thurman read the resolution providing voting rights to Michael Byrd or Aaron Randolph at Wilbur Mills Co-op in Dr. Thurman's absence.

**CACFP Snack Program Resolution** – Dr. Thurman read the resolution authorizing the district to participate in the CACFP Snack Program for pre-k students.

**2024-2025 School Meal Prices** – Dr. Thurman reported that school meal prices will stay the same for the 2024-2025 school year and the district will continue with the free breakfast program.

2024-2025 Food Service Bids – Dr. Thurman presented the food service bid recommendations:

- 1) Sysco Foods of Arkansas as the prime vendor for all food products, paper supplies, and chemical products.
- 2) American Paper & Twine as a secondary vendor for paper products.
- 3) Dawn Wholesale as the prime vendor for all bread and water products.
- 4) Hiland Dairy as the prime vendor for all milk products.

5) L & J Restaurant Holdings, DBA Pizza Pro of Cabot for all pizza products.

**2024–2025 Gate Admission** – Scott Reed and Kasey Wylie presented a proposal to increase gate prices from \$5 to \$7, except for 7<sup>th</sup> grade sports, which will remain at \$5. This increase is due to the increase cost of officials and equipment.

**Resolution to Sell District Property – Fine Arts** – Dr. Thurman read the resolution to authorize the sell of old lighting equipment from the fine arts department at the high school.

**Resolution to Sell District Property – Band** – Dr. Thurman read the resolution to authorize the sell of band show items from "Cadence of the Canopy" and winter guard items from the winter guard show "Poses."

**Resolution to Sell District Property – 404 North Second Street** – Dr. Thurman read the resolution to authorize the sell of the property at 404 North Second Street via bids with a minimum price of \$425,000.

**Resolution to Sell District Property – 1348 West Main, Austin** – Dr. Thurman read the resolution to sell the property located at 1348 West Main in Austin via bids with a minimum starting price of \$3,500.

**2024-2025 Student Handbook** – Dr. Thurman shared that two additional changes were made to the prohibited conduct section since the board last saw the proposal.
