Transportation Program Presentation – Transportation Director Morris Rothfeldt provided an overview of our current bus fleet and a proposal of a bus lease program. We currently have 118 buses on the lot and run 88 routes a day. A brand new bus costs around \$100,000, and the newer buses have more expensive problems due to equipment required by emissions standards. Entering into a lease program would provide the district with new buses every few years and any repair costs would be covered by the manufacturer.




